2. **The Mwanza City Director** now invites eligible Company/Individual consultants to submit proposals for provision of services outlined below. Proposals must provide information indicating that they are qualified to perform the services i.e qualifications, description of similar assignments, experience in similar conditions and availability of personnel with proven skills and experience in the assignment.

Interested **consultants** (Individuals) will have to provide Technical proposal indicating that they are qualified to perform the service by submitting updated CV's, description of similar assignments, experience in similar assignments, their understanding of Terms of Reference and relevant skills. They must also submit a separate **Financial Proposal** for the said services.
4. Consultants should submit their proposals; one signed original Technical and Financial Proposal by **11<sup>th</sup> May,2017 at 10:00 A.M.** The detailed Technical Proposal and Financial Proposal shall each be enclosed in a separate envelope and marked "**Proposal for Design And Supervision of the Installation of Abattoir Facilities**" and submitted to the **Tender Board Secretary, Mwanza City Council, P.O.BOX 1333, Mwanza**
5. The opening of Technical Proposal shall take place immediately after the deadline for submission at the Mwanza City Council Conference Hall 2<sup>nd</sup> Floor of the main building, located at the junction of Balewa and Machemba Roads.
6. Consultants will be selected in accordance with the quality and cost based selection (QCBS) method and procedures set out in the Public Procurement Act No. 7 of 2011 and Regulations - Government Notice No.446 of 2013.

7. Technical and financial proposals shall be evaluated on the basis of the criteria shown in the Terms of Reference. Only Individual Consultants scoring 75 Percent and above shall be engaged (depending on the availability) to carry out the assignments during the financial year 2016/2017.
8. Prospective Individual/institutions Consultants are required to collect Terms of Reference from the office of the **Secretary of Tender Board, Mwanza City Council, P. O. Box 1333, Mwanza** as from **8:00 am to 3:30 pm local time** on Mondays to Fridays inclusive except on public holidays.
9. Any request for clarification with regard to this assignment shall be addressed to the Secretarial of the Tender Board. The Client shall respond in writing only to clarifications received not less than one week before the deadline for submission.
