1. The Mwanza City Council has received funds for Local Government Capital Development Grant from the CENTRAL GOVERNMENT during the financial year **2016/2017**. It is intended that part of the proceeds of the funds will be used to cover eligible payments under the contract for Construction of male ward at Nyamagana Hospital in Mwanza City Council.
2. The Mwanza City Council Director now invites sealed bids from National Service Contractors Class five and above who produce national service (i.e. **SUMA JKT, VETA,TBA .e.t.c**) for executing the works as described below.

 - v) Proof Registration for Tax Payers identification Number (TIN) and VAT Registration.
 - vi) Plants and Equipments owned/hired to be deployed (lease evidence should be submitted).
 - vii) Proof of availability qualification and experience of key site management and technical personnel proposed for the project.
 - viii) The latest six months Bank Statement.
 - ix) Work Programme and time of completion
 - x) Power of Attorney
 - xi) Anti-bribery.
4. A bidder may bid as indicated in the schedule of requirements.

5. Interested eligible Bidders may obtain further information from and inspect the Quotation Documents at the **Office of the Secretary of Tender Board Mwanza City Council, P.O.BOX 1333 Mwanza** as from 8:00 am to 3:30 pm local time on Mondays to Fridays inclusive except on public holidays.
6. All bids in one original plus two copies marked **“TENDER NO. LGA/089/2016/2017/W/02 FOR CONSTRUCTION OF MALE WARD AT NYAMAGANA HOSPITAL IN MWANZA CITY COUNCIL NOT TO BE OPENED BEFORE 10:00 A.M”**, properly filled in, and enclosed in plain envelopes must be delivered to the address:- The Secretary, Mwanza City Council Tender Board P.O.BOX 1333, Mwanza and be deposited in the Tender Box before the Deadline for submission of tender.
7. The deadline for submission of tenders is on **Thursday 11th May, 2017 at 10:00 am**. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening at the Mwanza City council Conference Hall second floor of the main building ,located at the junction of Balewa and Machemba Roads.
8. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
