1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Sunday News media Issue no ISSN 0856-3812 (No:32326) dated Sunday,23th April,2017 and Daily News media ISSN 0856-3812(No:11931) dated Sunday,24th April,2017
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the Mwanza city council roads during the financial year **2016/2017**. It is intended that part of the proceeds of the funds will be used to cover eligible payments under the contract for routine maintenance, spot improvement ,periodic maintenance works and construction of Culvert and Bridges along selected roads within Mwanza city Council.

The Mwanza city council received/has applied for/intends to apply for a grant from the **ROAD FUND BOARD** towards the cost of road funds project, and it intends to apply part of the proceeds of this grant to cover eligible payments under the contract for **Maintenance of Mwanza City Council Roads. A complete set of Tendering Document(s) in *ENGLISH* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tanzania Shillings one hundred thousand (Tshs. 100,000.00) per each Lot.** Payment should either be by Banker's Draft, or Banker's Cheque, payable to **Director, Mwanza city council, P.O.BOX 1333,Mwanza.**

All Tenders must be accompanied by a **Tender security** in an acceptable form in the **amount of 2%** of Tshs applies/request for solicitation document. i.e. form of Tender and All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet. During the submission of Tender document the following information should be enclosed as detailed below:-

8. A bidder may bid for one or more Lot(s) in any bid as indicated in the schedule of requirements.

LGA/089/2016-2017/W/01 FOR MAINTENANCE OF MWANZA CITY COUNCIL ROADS NOT TO BE OPENED BEFORE AT 10:00 A.M"**, properly filled in, and enclosed in plain envelopes must be delivered to the address: - The Secretary, Mwanza City Council Tender Board P.O.BOX 1333, Mwanza and be deposited in the Tender Box before the Deadline for submission of tender at 10:00 am.
10. The deadline for submission of tenders is on **Friday 11th May, 2017** at 10:00am. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening at the Mwanza City Council Conference Hall second floor of the main building, located at the junction of Balewa and Mchemba Roads.
11. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
